Join us in ending U.S.-sponsored torture

In 2014, NRCAT's targeted advocacy in support of releasing the Senate Intelligence Committee's report on CIA torture led to an impressive 11-3 bipartisan vote to release the executive summary, findings, and conclusions of the report. On December 9th, those sections - the "Torture Report" - were made public.

As the nation reacted with horror to the graphic descriptions of the CIA's immoral, illegal, and ineffective torture program, NRCAT organized op-eds and meetings of faith leaders to condemn the CIA's use of torture, went on CNN, and sent action alerts to every state urging action in Congress to ensure that the torture program is never repeated.

NRCAT is now working with Congress and the Obama Administration to use evidence uncovered in the report to craft and pass legislation that will strengthen the legal prohibitions against torture.

Regularly, NRCAT faith leaders in Washington, DC meet with White House and State Department officials to encourage the Administration to more quickly transfer detainees out of the Guantanamo Bay detention center. NRCAT worked successfully with Members of Congress to oppose additional restrictions on transfers proposed in Congress in 2014.

Join us in changing policy to eliminate the use of solitary confinement

In 2014, NRCAT network members offered faith leadership to a growing national movement of state campaigns and joined in national and international hearings to end the torture of solitary confinement. NRCAT members gave testimony at state hearings on solitary confinement in California, Maryland, New Jersey and New York, met with elected and appointed officials, conducted clergy visits to state prisons and city jails, and stood up for local, state, and national human rights at every opportunity.

In September, NRCAT submitted an interfaith Shadow Report to the United Nations Committee Against Torture for their review of the U.S. government under the Convention Against Torture (CAT). The Shadow Report was endorsed by more than 15 religious organizations and was included in the Executive Summary of the US Human Rights Network report. It spotlights the human rights and moral implications of the torture of solitary confinement in U.S. prisons, jails, and detention centers, particularly the disproportionate impact on people and communities of color.

State level campaigns to end solitary confinement:

NEW YORK

NRCAT joined the New York Campaign for Alternatives to Isolated Confinement (NY CAIC) to support the passage of the HALT Solitary Confinement Act and in August co-sponsored an interfaith delegation of 30 faith leaders to visit the NYC Rikers Island Jail complex, which included an appointment with Commissioner Joseph Ponte.

PENNSYLVANIA

NRCAT organized an interfaith delegation of state faith leaders to visit punitive segregation at SCI-Greene, meeting with PA DOC Secretary John Wetzel and followed-up in early December by submitting a transition memo on solitary confinement to incoming Governor Wolf.

NEW JERSEY

State Senator Raymond Lesniak introduced a bill to curb the use of solitary confinement in NJ, drafted in collaboration with NRCAT, ACLU NJ, AFSC, persons currently incarcerated and members of the mental health community.

Join us in addressing anti-Muslim bigotry

In 2014, NRCAT expanded our partnerships with Arab, Middle Eastern, Muslim and South Asian communities in the U.S in order to address anti-Muslim sentiment and related bigotry. NRCAT also continued to provide leadership to the Shoulder-to-Shoulder campaign. Shoulder-to-Shoulder brings together national Jewish and Christian organizations to oppose Islamophobia and in 2014 expanded its grassroots network to equip rapid response to confront anti-Muslim bigotry.

Randy Brinson, head of the Christian Coalition of Alabama, joined NRCAT and others to oppose Amendment 1, a November 2014 ballot initiative that would prohibit "the application of foreign law" in the courts. NRCAT signed-up 30,000 Evangelicals and Catholics in Alabama to pledge to vote against the measure, one of the largest religious moderate voter education campaigns ever coordinated in Alabama.

Education and Outreach

Education and outreach is critical to movement building and policy change. In 2014, NRCAT faith leaders, board members, and staff continued our steady pace of messaging and engagement through education and public witness events, social media, letters to the editor and opinion pieces.

On Human Rights Day 2014, NRCAT issued its inaugural e-newsletter, *Human Rights Faithfully*, along with a webinar featuring UN Special Rapporteur on Torture, Prof. Juan Mendez and Dr. Rebecca Gordon, author of *Mainstreaming Torture*.
